Prior Version: Humbly, on our knees, asked Him to remove our shortcomings.

When we did our 4th Step, assuming that we were both thorough and honest, we noticed patterns beginning to emerge as we navigated the various columns of our inventory. We could readily see the dishonesty, selfishness, and greed that was, in fact, our "mode of living". We prayed or meditated on these facets of our lives, asking to be given the strength next time to "do the right thing". As we mature in sobriety, we find that it's easier to keep doing that next right thing more

Tradition Seven and Concept VII Helps Us Understand the Meaning of Prudence

As I've pointed out in prior essays, it helps in understanding a Tradition or a Concept, to look for personal applications. Tradition

Seven concerns self-support. Am I supporting myself, is the Group supporting itself, and are the Trustees of the

General Service Board supporting the conscience of the General Service Conference?

Money: too much or not enough, is the subject of Tradition Seven. Too much money—as in the large donations that would flood in to A.A. if we allowed it—and the Group would begin to lose sight of just what our primary purpose is. Too little, and we could not pay our rent or support the important activities of the General Service Conference and our local Intergroups in being there as a vital resource for alcoholics who are suffering and do not know where to turn.

Prudence, seems to be the cornerstone principle for both Tradition Seven and Concept VII. I know that, for me personally, too much money can make me drunk: first, drunk with myself and my ego; then perhaps literally so! As it says in the Tenth Step, "big shottism" is and has been, a recurring problem for me. Practicing prudence with my own finances has been and is, a daily challenge. According to Tradition Seven, not only must a Group be "self-supporting, but it must be careful to maintain only a "prudent" reserve.




what to do with a large sum of money on hand. Here is also a place to remind the Group to contribute its excess funds ("excess" here meaning, "beyond a prudent reserve for operating expenses") up to the District, Intergroup, and the General Service Conference in New York. It is these entities that provide the lifeline points of contact with the millions still out there suffering from this disease and not knowing

where to turn.

Concept VII takes the principle of prudence to another level still. The Concept, while recognizing that the General Service Board Trustees are, for all intents and practical purposes, in charge of managing A.A. as an international entity, places a final "check" on any unlimited power that such responsibility might entail. It states, once and for all, that the ultimate authority within A.A. remains always with the A.A. group conscience, as that may be expressed through and by the individual group delegates to the General Service Conference. At any time, the General Service Conference can step in and block a proposal or an action by the Trustees, where the Conference feels that the Trustees are just not acting prudently on a given issue. Not, of course, that this has occurred in anything but rare instances in A.A.'s history. Nevertheless "prudence", as expressed by the General Service Conference, remains firmly enshrined in A.A.'s history and its daily functioning, and Concept VII makes that clear.

often, and our inner peace grows to the point that we would no longer even consider the "not right" thing when the situation presents itself next time.

From my own experience, as I became better at "Letting Go and Letting God", my serenity increased incredibly, and I could handle those situations that always seemed to trip me up and send me reeling back to my "old ways". My friends and family commented that I had a "right" to be upset with someone or something, but I found that if

I surrendered instead of becoming angry or planning retaliation, I slept a lot better, and that wasn't the only reward. The trick for me was in avoiding that "knee-jerk" reaction I had practiced for so many years, and just taking a minute to think prior to acting. That short span of time proved to be time well spent, in terms of my comfortableness with myself. Being happy when looking at that person in the mirror in the morning is the other part of the reward. Practice, practice, practice. Eventually you'll get it right! ;-)

drink is to die. But being blessed to be the Chair of SJIG, I do not govern and I try not to control (emphasis on try).


At best, I am a trusted servant, entrusted to facilitate the smooth and effective operation of Intergroup. I have said on more than one occasion, If the service one does is always convenient, then perhaps it isn't service. A good friend reminded me of that recently, for which reminder I am grateful. Service in AA is not about getting what you want, it is about helping others, doing what is in the best interest of AA as guided by group conscience. Service is about putting the needs of others ahead of my own.

Unity requires us to work together, not fight each other. Our Twelve Traditions guide us in how to work together, starting with Tradition One – personal recovery depends on AA unity (it's not about me), and, Tradition Two – a

loving God expressed through group conscience, through Tradition Twelve - anonymity is the spiritual foundation of all our traditions (it's not about me). At SJIG, the Steering Committee, which is comprised of the elected panel (Chair, Vice Chair, Treasurer, Ass't. Treasurer, Secretary and Ass't. Secretary), Trustees, Committee Chairs and Co-Chairs. meets once a month to discuss the details of the day to day operations of SJIG. Some of the Committees have monthly meetings as well is discuss the efforts of those Committees. The reports of each Committee and the minutes of Steering Committee are distributed at the regular Intergroup meeting, attended by the Intergroup Representatives, so that business may be conducted, questions may be asked and actions of the Committees and Steering may be communicated to the participating home groups. Without the participating home groups, there is no Intergroup. Intergroup is the coming together (Unity) of volunteers (Service) to carry the AA message (Recovery).

SJIG has experienced increased participation over the past few years, thanks in large part to the efforts of our Unity Committee, which has brought in new Intergroup Representatives. I am grateful for the service of each Intergroup Representative, our Committee Chairs and Co-Chairs, our Trustees and the members of the elected panel. Thank you for your service. SJIG has many opportunities for service.

In six months, SJIG will need new elected panel members, new Committee Chairs and Co-Chairs, and new Trustees. You could be one of them!
